TERMS: The terms and conditions of this application shall, upon extension of credit to Applicant by BIERSCHBACH EQUIPMENT & SUPPLY, constitute a credit agreement between Applicant and BIERSCHBACH. Applicant agrees that each of the terms and conditions of sale stated on the Sales Invoice provided by BIERSCHBACH shall be made a term of the contract of each sale from BIERSCHBACH to the Applicant. Credit shall be extended at the sole discretion of BIERSCHBACH, and BIERSCHBACH may increase, decrease, or terminate any credit availability at any time within its sole discretion. Applicant agrees to pay to BIERSCHBACH: (1) all Sales Invoices by the tenth (10th) day of the month following billing or as otherwise stated on Applicant's Sales Invoices or Statements and, if not paid on or before said date, such Sales Invoices may then be considered delinquent by BIERSCHBACH; (2) interest charges on any delinquent Sales Invoices at the rate of 2 percent per month (24 percent per year) or the maximum rate of interest allowed in South Dakota, whichever is less; and (3) all costs of collecting delinquent Sales Invoices and interest charges, including court costs, reasonable attorney fees, and collection agency fees. Interest charges associated with any delinquent Sales Invoices shall be no less than \$5.00 per month. Waiver of any one or more interest charges shall not be deemed to be a waiver of future interest charges.

The terms of this application shall be construed under the laws of the State of South Dakota. If any provision of this application is held void or unenforceable, the validity or enforceability of the remainder of this application shall not be affected and the void or unenforceable term shall be amended such that it is enforceable to the maximum extent permitted by law. Applicant acknowledges that this credit application is for business and commercial customers only and any credit provided by BIERSCHBACH in connection herewith is not to be used for the purchase of equipment or services for personal, household or family purposes.

Applicant authorizes BIERSCHBACH to obtain credit and financial information concerning the Applicant at any time and from any source. Applicant expressly authorizes and consents to any contact with or inquiry of any person, individual, or entity of any kind regarding the credit history or other financial information or references of Applicant and each business owner, partner, officer or manager of Applicant, including bank and trade references and information furnished by credit reporting agencies. Applicant consents to BIERSCHBACH's use of such information in connection with any decision to extend or terminate credit to Applicant. Applicant agrees to release and hold harmless BIERSCHBACH from, and indemnify BIER-SCHBACH for, any claims or liabilities in connection with such inquiry. Applicant agrees to promptly notify BIER-SCHBACH of any changes to information on the credit application, in writing, at the address shown above.
